


#### **AVAILABLE STORM SHELTER**

#### SERVICE LINE INVENTORY REMINDER

Approximately 60 days ago, Calhoun water customers should have received a letter in the mail asking you to identify your water service lines. In order for the City to comply with an EPA mandate, all cities are required by law to inventory all water service materials from the water meter into the home. If you have not answered the letter, we ask that you do so promptly to assist in our efforts to comply. Refusal to respond could potentially require personnel or a contractor to come to your home to obtain the EPA information



and/or dig a hole in your yard outside of the city's easement. Please understand that a quick response to this customer survey is one of the most helpful things you can do as a citizen to help accomplish this mandate.
